TRAINING LEGAL LANGUAGES FOR EFFECTIVE FUNCTIONING OF JUDICIAL COOPERATION IN EU JUST/2014/JTRA/AG/EJTR/6762

The project aims at improving professional legal language knowledge of judges and prosecutors from 5 EU Member states in the region of Central and Eastern Europe, and at contributing to the consistent and effective implementation of EU law. Project is coordinated by the Czech Judicial Academy in cooperation with 4 other partners - Croatian Ministry of Justice, Polish Judicial Academy, Slovakian Judicial Academy and Slovenian Ministry of Justice. The project not only focuses on providing legal language knowledge but also professional knowledge in the framework of seminars covering different aspects of EU law and judicial cooperation in criminal, civil and commercial matters. The project thus aims to contribute to development of mutual trust among EU Member states and to improvement of cross-border cooperation.

Key Activities

- preparation, organization and evaluation of 6 interactive legal language seminars of English (4) and German (2) for 121 judges and prosecutors with main focus on judicial cooperation in criminal matters and in civil and commercial matters + 1 follow up course;
- preparation, organization and evaluation of the conference for 40 trainers and experts to enable sharing best practices and methods, analysing future training needs and setting standards in the area of legal language training;
- development of training materials in formats enabling their use for face-to-face learning and blended learning;
- setting standards for legal language training for the future.
